DRAINAGE MANAGEMENT

Mr. McCoy updated the board on the following practices on the San Joaquin River Improvement Project:

- a. The incoming drain flows to the Project have been very low so far this summer. This is mainly driven by the fact that the participating districts are struggling with limited surface water supplies and thus is limiting the amount of drain water produced within the 100,000-acre boundary.
- Revenue on the Jose Tall Wheat Grass is good

- c. Staff is working on a long-term maintenance program for all pumps, motors and equipment
- d. The Project will irrigate approximately 80% of the land that is currently in production this year

WIIN ACT CONTRACT CONVERSION UPDATE

a. Validation Action

Ms. Layne stated that the final order was received for the Validation Action. This is very good news.

- b. Reclamation Reform Act (RRA) Compliance: Mr. Hurley stated that district staff is still waiting to hear from the Bureau's Denver Colorado office on the status of the Final Letter that will proclaim Pacheco is fully divested of its obligations under RRA. Staff has been told that the letter should be sent out in the very near future.

OPERATIONS: Mike Gardner

a. Routine Maintenance Update: The Water Operators are continuing to focus on routine maintenance items as well as coordinating the aquatic herbicide applications with Panoche Water District. President Barcellos asked if District staff was performing the herbicide applications on the off-banks of the canals and drains. Mr. Gardner stated that the work is performed by a qualified and licensed outside contractor hired by the district. Mr. Gardner also stated that having a backhoe on site to perform general maintenance throughout the district will provide long term benefits in terms of efficiency and cost savings.
