# PACHECO WATER DISTRICT SPECIAL MEETING OF THE BOARD OF DIRECTORS MEETING MINUTES April 8, 2021

**CALL TO ORDER:** 

President Barcellos called the meeting to order at 1:04 pm.

## WATER SUPPLY UPDATE

Mr. Hurley reported that the Central Valley Project watershed has been very dry this year. The 5% water allocation that the Bureau of Reclamation (BOR) allocated to us in March has been put on hold. The BOR has allocated Pacheco Water District 5%, but currently the District does not have access to the water. The BOR does not know if they have enough water to meet cold water temperature demands out of Shasta Reservoir. The BOR will probably decide mid to late summer whether they can actually delivery the 5%.

# THE BOARD TO REVIEW AND CONSIDER APPROVAL OF THE 2021 WATER RATE

Staff reminded the board that the Bureau allocation of 5% is still not available for delivery and may not be accessible for the entire year. Therefore, the attached water supply spreadsheet has a zero amount under 2021 USBR allocation. Pacheco has applied for their pro-rata share of 2021 Yuba water and North of Delta water through the San Luis and Delta Mendota Water Authority (SLDMWA). Those projected amounts and associated costs (approximately \$1,000/acre foot) were reviewed with the board. President Barcellos mentioned that this water is very expensive, but with limited options, he agrees that we should purchase the water and ultimately the overall average water costs to the consumer would be cheaper due to the lower rate that Pacheco pays for the CCID water. The balance of the directors agreed with President Barcellos. Mr. Hurley reminded the board that under the current methodology, Pacheco does not blend all their water into one pot and then bill out a blended rate to its customers. Therefore, customers will get monthly bills specifically for the water acquired from the SLDMWA that will be at a delivered rate above \$1,000/acre foot. Upon a motion by Director Smith and seconded by Director Levake, the board unanimously approved setting the 2021 CCID water rate at \$157.00 per acre foot.
